A Message from the Board President...

Dear Cooperative Leaders:

While scrolling on my phone, I came across an article that said, of the world's population

- 77% of the world's population has housing, meaning 23% are homeless
- 21% can eat in excess and 63% can eat as much as they want, meaning 15% are malnourished
- 87% have ready access to clean drinking water while 13% do not, and
- 91% of the world's population has electricity, a high number but that still means 9% do not

I don't believe that just because it was on the internet it must be true so I won't argue that these numbers are exactly correct. Even if the numbers are only in the ballpark, if you have food, water, shelter and electricity, you are in a small and fortunate minority.

If you want to narrow down this small group even more, look at the percentage of people who have all those basic needs and can also say they have fulfilling work that challenges them. If you're reading this, I expect you're part of that even more select group.
