Mr. Doug Miller Shares Rural Electric's Approach to Director Training at MACC Annual Meeting

The Mid America Cooperative Council hosted its 2024 Annual Member Meeting virtually on Thursday, April 11, 2024, to recognize the Council's accomplishments, welcome new and returning directors, and share ideas about director development.

A highlight of the meeting was the presentation, "Electric Cooperative Approach to Director Education," by Mr. Doug Miller, Vice President, Statewide Services of <u>Ohio Rural</u> <u>Electric Cooperatives, Inc</u>. (OREC) Mr. Miller addressed the significance of cooperative director education, particularly in the context of the 5th Cooperative Principle -- Education, Training, and Information.

As a statewide association of 25 electric cooperatives that serve more the 380,000 homes and businesses, OREC offers vast education and training opportunities to electric co-ops across the state.

From biannual conferences to new director orientation, and more, Miller highlighted the importance of helping directors understand their unique responsibilities and the business environment of their



co-ops. OREC supports directors, including by hosting certificate classes offered by the National Rural Electric Cooperative Association, which serves 831 distribution cooperatives and 63 generation and transmission cooperatives.

MACC and CFAES Center for Cooperatives Exploring Director Development Program for Mid America

At the 2024 Annual Member Meeting, MACC's directors shared that the board and management team at the College of Food, Agricultural, and Environmental Sciences Center for Cooperatives at Ohio State are exploring developing an annual, foundational development program for cooperative directors in the Midwest.

The goal of the program would be to help directors build a strong foundation in cooperative governance to be better leaders throughout their leadership journey. The in-person, regional training would explore key governance areas like director responsibilities, financial planning, CEO and board management best practices, and more, to give directors a regular opportunity to grow their skills and network with peers.


